#### **1) Welcome and Introductions**

- a) Bay Area Region reported that they are planning 2 focus groups in Bay Area with the CRDP Latino SPWs.
- b) The Southern Region announced that the Southern Region Cultural Competence Summit will be at the Ontario Convention Center, November 2 & 3. The name of conference is Honoring Promises – Impacting Learning.
- c) The Central Region announced that they are awaiting responses for their submitted Cultural Competency Plans. CBMCS need/interest in adding spirituality info. SPWs meetings scheduled for the central region soon. At the last central region meeting the group identified priority materials for revision/correction by the OMS-DMH contract.

- a) Next Steps on Scoring Tool and Review Process regarding CCPR.
  - i) Training & Scoring. The reviewers have been trained and they are reviewing. There is a 30-day review process and then they come together to discuss scores and discrepancies. From this discussion they develop a summary report.
  - ii) Small County Process – Working on modifying the tool and recruiting small county reviewers. Hoping for more reviewers at this time. Eleven counties have submitted and twenty granted extensions. OMS working on comments and feedback for small county review tool for CCPR.
- b) MHSA Multicultural Coalition. From their first meeting on March 28, they established 4 committees, Administration, Emerging Leaders, CRDP and MHSA Recommendations, the next meeting is June 29.
  - i) CPEHN is starting to review drafts of strategic plans from the SPWs. The ESC would also want to see/review the drafts.
  - ii) Check DMH website for upcoming meetings info.
- c) Statewide Data Evaluation on MHSA.
