2) Report /Issues from Regional Chairs

- a) Bay Area Region. Alameda County had great turnout at June 15 Latino SPW meeting with 7 counties represented.
- b) Southern Region. Meeting monthly to plan for CC Summit. Good sharing among counties; cultural competency advisory committee. Offering support to each other. Orange County INN funding has been suspended. Board investigating controversial issue involving Latino Health Access PEI grant in Orange County.
- c) Central Region is focusing on continuing to work with SPW/API to get workgroup. Collaborate with API workgroup.
- d) Superior Region. Big turnout for June 14 & 15 Northern California Latino Conference with 102 participants, various counties. How MHSA is impacting services.

- a) Next Steps on Scoring Tool and Review Process regarding CCPR.
 - i. CMHDA requested an extension and then submitted feedback on June 10, 2011. At this time, DMH is finalizing the document and then will submit it to executive leadership at DMH for final approval.
 - ii. CCPR Review Process will likely be complete in July 2011. CCPR Reviewers have 30 days to review and score the county CCPR submissions.
 - iii. To date, 13 counties have submitted their CCPR Modification.
