<b>*2</b>	The committee continues to work to find counties willing to be part of the pilot project for the Milestones of Recovery Scale (MORS) Inter-Rater Reliability Study.

<b>*4</b>	The committee has pursued training opportunities for older adults at all levels for the workforce, with the help of CIMH and Heritage Clinics.
<b>*5</b>	The committee had a presentation in February from Eskaton on Adult Day Health Care.
